This is a summary of the annual report for the Sheet Metal Workers Local No. 71 Industry Welfare Trust Fund, (Employer Identification No. 16-0864434, Plan No. 501) for the period January 1, 2021 to December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The value of plan assets, after subtracting liabilities of the plan, was \$7,161,683 as of December 31, 2021 compared to \$6,796,147 as of January 1, 2021. During the plan year the plan experienced an increase in its assets of \$365,536. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$5,542,451. This income included employer contributions of \$4,723,877, employee contributions of \$53,844, realized losses of \$24,023 from the sale of assets, earnings from investments of \$226,660, stop loss reimbursements of \$205,647, prescription rebates of \$256,522, and other income of \$99,924. Plan expenses were \$5,176,915. These expenses included \$557,890 in administrative expenses and \$4,619,025 in benefits paid to participants and beneficiaries.
